

Australians and their Pets **The FACTs**



Australia's Pet Owning Population

- More than 63% of Australian households own a pet, of these:¹
 - 40% own dogs
 - 26% own cats
 - 53% own a dog and/or a cat
- At 63%, Australia has similar pet ownership as the USA², while only 43% of UK homes own a pet.¹
- In about two-thirds of cases a woman is the main carer and decision-maker in relation to the family pet(s).³
- 91% of pet owners report feeling 'very close' to their pet, reinforcing that pets are an integral member of the family unit, however constituted.¹
- More than 83% of Australians have had a pet at some time in their lives.¹
- Of the people who do not currently own a pet, 53% would like to own one in the future.¹
- In total, 44,700 Australians are employed in the pet care industry.⁴

Health Benefits of Pets to Australians

Compared with non-pet owners:

- People who own pets typically visit the doctor less often and use less medication⁵
- Pet owners, on average have lower cholesterol and lower blood pressure⁶
- Pet owners recover more quickly from illness and surgery⁷
- Pet owners deal better with stressful situations¹
- Pet owners show lower levels of risk factors associated with heart disease¹
- Elderly pet owners report an increased quality of life and companionship⁸
- Pet owners are less likely to report feeling lonely⁹



The Economic Benefits of Pets

- The pet care industry is one of the largest in Australia
- It contributes around \$4.74 billion to the economy annually and employs over 44,700 people
- In comparison, the poultry industry and poultry products industry turns over \$3.5 billion per annum
- Of the total expenditure on pets 58% is spent on dogs, 28% on cats and 14% on other pets
- The annual national health cost saving resulting from pet owners visiting the doctor less often is estimated to be up to \$2.227 billion¹⁰
